GENERAL ORDER

A significant number of cases seeking review of a decision by the Commissioner of the Social Security Administration to deny benefits are filed in this district. The Court is interested in facilitating the efficient resolution of those complaints. To this end, the Court has adopted the following rules pertaining to all complaints instituted by a plaintiff against the Commissioner in which the only claim that is being brought is pursuant to 42 U.S.C. § 405(g).

THE COURT HEREBY ORDERS:

(1) No later than service of the summons and complaint, the plaintiff shall provide the United States Attorney's Office for the Northern District of Oklahoma ("USAO-NDOK") and the Denver Office of Regional Counsel for the Social Security Administration ("Denver ORC") with the full name and last four digits of the social security number of the individual whose benefits application was denied. This identifying information is necessary for the Commissioner to obtain and produce the certified administrative record. This information shall be provided to the USAO-NDOK and the Denver ORC by email at USAOKN.ECFCivil@usdoj.gov (or by delivery, by hand or mail, to "SSA Clerk Civil Division" at 110 W. 7th Street, Suite 300, Tulsa, OK 74119) and to OGC.DEN.Service.NDOK@ssa.gov (or by delivery, by hand or mail, to "SSA Clerk Civil Division" at 1961 Stout Street, Suite 4169, Denver, CO 80294).

(2) Within 91 days following service of the summons, complaint, and identifying information on the USAO-NDOK and the Denver ORC, the Commissioner shall file the certified

administrative record in electronic format and serve it on the plaintiff. Taking such action shall serve as the Commissioner's Answer. No separate Answer need be filed.

(3) The effective date of this Order is July 22, 2016. The Court reserves the right to modify this order from time to time, or to rescind the order entirely, as the Court determines necessary in light of experience.

(4) The Court Clerk shall post a copy of this Order on the Court's website, and shall distribute copies as the Clerk deems appropriate.
