**FINDS**, the following individuals are hereby appointed by majority vote of the district judges of the Northern District of Oklahoma:



The Panel members shall review the incumbent's current service as magistrate judge and other experience, the comments from members of the bar and public, and other evidence of the

incumbent's good character, ability, and commitment to equal justice under the law, and conduct interviews and other necessary inquiries until they are satisfied they can recommend to the Court reappointment of the incumbent as a full-time United States Magistrate Judge. The Panel shall commence on July 5, 2016, and report to the Court within ninety (90) days thereafter, or by October 3, 2016, whether the incumbent, T. Lane Wilson, is recommended for reappointment.
