

IT IS SO ORDERED this 28<sup>th</sup> day of March 2008.





**HOME CONFINEMENT/CURFEW PROGRAM  
PARTICIPANT AGREEMENT**

---

You have been placed on a Curfew or in the Home Confinement Program. The following conditions have been approved by the Court and are thereby added to your conditions of supervision until you have been released from the program. Failure to comply with this agreement or the instructions of your officer will be considered a violation of supervision and may result in adverse action.

1. I agree to contact my officer immediately if I have any questions about these rules or if I experience any problems with assigned monitoring equipment.
2. During Home Confinement, I will remain at my approved residence at all times except for activities approved in advance by my probation officer. During a Curfew, I will remain at my approved residence during my established curfew times except for activities approved in advance by my probation officer. Schedules will normally be approved for the following:

Employment  
Medical/Dental Appointments  
Meetings with Attorneys  
Church Services

Other activities requested by the participant **may be considered** by the probation officer; however, those requests can be denied without stated cause.

3. I will not deviate from my schedule unless an emergency situation arises. Should an emergency situation arise, I am authorized to deviate from my approved schedule. I will contact my probation officer as soon as possible and provide proof of the emergency as requested.
4. If required by the Court or Probation Office, I agree to wear a non-removable transmitter and I understand that tampering with the transmitter is a violation of the program.
5. I agree to maintain electrical service in my residence at my own expense. If required by the Court or Probation Office, I will maintain compatible telephone service at my

residence, and to the telephone line upon which any assigned monitoring equipment is connected, I will not have a cordless telephone installed or any special services such as call notes, answering machines, call forwarding, or call waiting, etc. I agree not to tamper with or unplug the assigned monitoring equipment unless authorized to do so by the probation officer.

6. I have been assigned the following equipment: \_\_\_\_\_  
\_\_\_\_\_ This equipment will be installed on my telephone and electrical lines and I understand that I will be held responsible for any damage done to the equipment. I understand that I may also be held financially liable and may be subject to felony prosecution for failure to return the equipment.
7. I understand that assigned monitoring equipment may operate on battery power and I agree to properly charge the equipment as instructed.
8. I understand that the monitoring equipment will continue to record my activity during times which I may be experiencing interruptions with my telephone or electrical service.
9. When I am at home I understand that I must promptly answer the telephone or the door when the probation officer is attempting to contact me. Should I not do so, I will be considered in violation of my curfew restriction or home confinement schedule. I understand that it is my responsibility to inform the probation officer of any and all locations where I may be employed and where I perform my job duties.
10. I understand that I must abide by all other conditions of supervision while under a Curfew or while serving in the Home Confinement Program.
11. I understand that I have been ordered to pay \$\_\_\_\_\_ per \_\_\_\_\_ For the cost of the program as directed by the Court and Probation Officer.

I acknowledge that I have received a copy of this document and that the warnings and conditions have been explained to me. I understand that I must comply with these conditions until \_\_\_\_\_, or until released from these conditions by the Court.
